Meeting Minutes for the Board of Directors

The meeting of the Board of Directors was held at the Church of Jesus Christ of the LDS, Knights Cross Drive, San Antonio TX.

The meeting was called to order at 7:30 pm.

Agenda was adopted.

The Board approved the minutes of the Nov 14 Board Meeting.

Executive Session was called. The Board discussed violation enforcement and possible actions to address the new apartment development on Wilderness Oak.

Treasurer Report: Julie reviewed the December 2018 end of year finances. The board approved placing unspent funds into money market accounts for respective areas (Common, Peak, Heights, Reserve) until the next reserve CDs mature in May, and decisions will be made at that time regarding placing funds into reserves or designating some funds for specific needs. The Pointe Interior had \$6000 unspent funds which will be utilized for Pointe improvements in coming months. Julie discussed that Alliance Bank reduced its interest rates for CDARs in late 2018, and options are being considered to obtain better rates.

- Peak Rocky Court pole light repair, replacing with LED bulbs, Suberg Electric, \$680
- Three reserve CDs were renewed in January.
- Peak fence repair, Benchmark, \$305.27

New Business

- The Board approved a proposal from Affordable Asphalt for \$5118.50 for Peak crack seal and one area repair.
- The Board approved a proposal from Quality Fence for Peak gate operators installation with required upgrades per state law at the Wilderness Oak entrance, \$13,000.
- The Board approved annual gate maintenance contracts for Peak, Heights, Reserve, \$650 each, Quality Fence.
- The Board approved annual gate camera/dvr maintenance contract for Peak, Quality Fence, \$300.
